Responsible Use of Social Networking Sites Policy

Guidance for Associations from ESFA

The following guidance is provided not as an obstacle but to support Associations to manage their safeguarding responsibilities effectively. It aims to ensure children, young people, coaches, referees and adults in a position of trust are not subjected to improper online behaviour or improper allegations.

If an Association decides that the most effective way of communicating to young people is via a social networking site then the Association is strongly advised to set up an account in the name of the Association and explicitly for use by named Association members, parents and carers solely about football matters e.g. fixtures, cancellations and team selection.

Coaches, referee mentors, Association officials and others in a position of trust in football need to act responsibly both on and off the field and this includes the use of electronic communications.

Therefore The ESFA/FA would suggest that as a general principle coaches, managers etc should avoid using social networking sites as the primary way of communicating with players. Children and young people should be advised by their coaches, parents/carers and Welfare Officer to always tell an adult they trust about communications that make them feel uncomfortable or where they've been asked not to tell their parent/carer about the communication.

The LSFA recognise following is best practice and as such our policy in relation to social networking

The LSFA will:

- Ensure all the privacy settings are locked on its social networking site so that that the LSFA account is used explicitly for Association matters and not used as a place to meet, share personal details or have private conversations
- Ensure that all players, parents/carers and LSFA officials will be provided with The ESFA/FAs best practice guidance on using social networking sites and this policy
- Ensure that all are aware they should inform the Welfare Officer (Mr Reidel) if they have received inappropriate communications online. A record of any inappropriate, threatening or offensive material will be kept as this may be needed as evidence.
- Ensure that all managers, coaches and association officials understand that unless a child/young person is a direct relation, the coaches, managers, referees, medics and Association officials should not:
 - I. Accept as a friend, any players or referees U18 on social networking sites they are members of personally or as a LSFA official, or share their own personal social networking sites with children or young people involved in youth football
 - II. Make contact with children or young people known through football outside of the football context on social networking sites
 - III. Use internet or web based communications to send personal messages of a non football nature to a child or young person
 - IV. Engage in any personal communications, 'banter' or comments

LSFA policy on the use of mobile phones and electronic equipment:

No electronic equipment capable of sending or receiving a message or picture/video is permitted at all by players or to be used by staff in changing rooms before, after, during games or training when players are there

Only staff are permitted to take electronic equipment capable of sending or receiving a message or picture/video on tours but these must not be used:

- in changing rooms before, after, during games or training when players are there
- in players rooms
